PacifiCare Secure Horizons Withdrawing from Alameda & Contra Costa County

- PacifiCare announced Monday that effective January 1, 2003, they will be withdrawing their Secure Horizons Medicare+Choice plan from Contra Costa and Alameda counties. This will affect more than 10,000 seniors who will need to find alternative coverage in the next few months. It follows PacifiCare's withdrawal last year from parts of Alameda and Contra Costa counties.
- Health Net Seniority Plus will continue with Affinity in 2003, although they will be withdrawing service with other medical groups in the Livermore area.
- The Affinity Board of Directors wants to reassure physicians, office staff and patients, that
 - 1) THESE CHANGES WILL NOT TAKE EFFECT UNTIL **JANUARY 1, 2003.**
 - 2) We understand current Secure Horizons Affinity members will have the option of enrolling in Health Net Seniority Plus for 2003.
 - 3) We will advise Secure Horizons members when they can convert to Health Net Seniority Plus—they will need to wait for the Seniority Plus open enrollment, since mid-year conversions are not permitted by Medicare+Choice plans.
- Affinity Seniors are NOT ALONE—According to Tuesday's San Francisco Chronicle, next year 200,000 Medicare patients will be dropped by U.S. health insurers around the country due to low government reimbursements in selected counties. Although HMOs have dropped more than 2.4 million Medicare patients nationwide since 1998, about one Medicare patient in seven is still covered by an HMO.
